Duties and responsibilities

Data collection, management, analysis and reporting

- Collect, verify and maintain datasets related to potato trade, production, consumption, sustainability and any other relevant topics.
- Monitor and compile EU and international statistics (Eurostat, FAO, Comext, etc.).
- Liaise with Europatat members and external partners to gather and consolidate data.
- Analyse trade trends, policy impacts and sectoral developments.
- Prepare statistical reports, data for infographics and summaries for members and policymakers.

Database and tools management

- Maintain and improve Europatat's internal databases and data management systems.
- Ensure accuracy, consistency and accessibility of data across projects.
- Contribute to the development of digital tools or dashboards for data visualisation.

- University degree in data science, economics, statistics, agricultural science, or a related field.
- At least 2–3 years of relevant experience in data management, preferably within an association, consultancy, or EU-related environment.
- Strong analytical and quantitative skills with excellent attention to detail.
- Proficiency in Excel and good command of data analysis or visualisation tools.
- Excellent command of English (both written and spoken).
- Strong organisational and communication skills, with the ability to work independently in a small team.

- Familiarity with EU institutions and agri-food or trade-related policies.
- Knowledge of statistical databases such as Eurostat, FAOSTAT, etc.
- Familiarity with the potato sector.
